- _____ **Boat and trailer must have current registration and insurance.**
- _____ **You must be a year-round resident of, or Active-Duty Military assigned to, Kodiak, AK.**
- _____ The slip is for your boat, if you choose to not use your slip, notify the MWR Boat House supervisor, at which time he'll issue the slip to another member to use it.
- _____ **Only one entry per household.**
- _____ **Slips will be drawn from a priority standpoint, with the previous year's winners, eligible only if not enough applicants have applied for the current year.**
- _____ No fueling or handling of petroleum products on or around dock.
- _____ No inoperable boats or trailers will be moored or parked in lot.
- _____ Boats for hire (including "Guide" boats, commercial vessels, etc) are strictly prohibited from moorage.
- _____ All children under 16 years of age are required to wear a life jacket while on the dock.
- _____ **You** are responsible for checking your boat during severe weather and periods of heavy rain.
- _____ **You** are responsible for keeping your contact information current with Boat house staff.
- _____ **You** are responsible for removing your boat upon request from the Boat house staff.
- _____ MWR is **not** responsible for any loss or damages which may occur to your boat while moored at the dock or trailers stored in parking lot.
- _____ MWR Staff who are moving MWR Boats have the right of way at the MWR docks and launch.
